IMPORTANT: While, BPAA membership is not cancelled until March of each year, Music Licensing fees are due on December 31st each year. The rates can not be offered to non members, therefore members wishing to participate in this program must pay all applicable local, state and national BPAA membership dues by January 15, 2009 (remember that you save \$2.00 a lane bed in doing so). Any music licensee fees for 2009 that a center paid will be returned to the center if dues are not received by this deadline. The center will then need to pay fees directly to the agencies at the non-member rate. NO EXCEPTIONS can be granted as this is a requirement by the licensing agencies and not BPAA.
